

Specific Terms and Conditions of the reward promotion Vodafone Albania and Coca-Cola Bottling Albania Sh.p.k

The terms and conditions of this Agreement constitute the entire agreement between the you, as a Vodafone client and Vodafone regarding the use of this promotion.

1. Coca-Cola Bottling Albania Sh.p.k, a limited liability company established and existing under Albanian laws, established by the Tirana District Court's Decision No. 5298, dated 26.06.1993, with residence at National Road Tirana - Durrës, km 5, Kashar, Tirana P.O BOX no.2939, Albania, registered in Tirana with NIPT: J61901061H.

2. Vodafone Albania Sh.A., a joint stock company established and existing under Albanian laws, established by the Tirana District Court Decision no. 25766, dated 10 May 2001, with residence in: Tiranë – Durrës Highway, “Pavaresia” Street, no. 61, Kashar, Tirana, Albania, with NIPT: K11715005.
 - All Vodafone customers who buy Coca-Cola products; Coca-Cola Zero; Fanta Orange; Fanta Exotic in 0.25L in glass bottles, 0.33L cans and 0.5L plastic bottles traded by CCBS during the duration of the promotion will have the right to be rewarded according to the description that appears on the promotional packages, as follows:
 - 500 MB bonus internet valid for 24 hours.
 - This promotion shall be valid from 1 July 2019 to 9 September 2019.
 - In each promotional package there will be a unique 8 - digits code.
 - Customers will activate the bonuses through the My Vodafone and Juth app. By accessing these apps the customers will be able to have the accurate guidelines on where to insert the code found on the CCBS products. After entering the 8 digits alphanumeric code found under the 0.5L plastic bottle cap, under the 0.25L glass bottles label and under the can opener for the 0.33L packaging, they will benefit from the 500MB bonus.
 - By entering the code, the system will reply if the code is valid or not and that the MB has been credited.
 - The customers have the opportunity to benefit up to 2, 500 MB of bonuses over the duration of the promotion each month.
 - If a customer obtains a bonus of 500 MB and a day later another 500MB bonus, the second bonus will superpose the first bonus and the validity date will be postponed in accordance with the second bonus.
 - The MB granted bonus will take precedence over all 4-week, weekly and daily bundles and less priority over SHAKE bonuses.
 - The balance check can be done by sending an empty text message to 131, from the My Vodafone/JUTH application or from the menu # 123 #.
 - Internet charging is made at intervals of every 10 KB.
 - The 500MB bonus is not valid in roaming.
